Preamble

The role of the African Diaspora in development policy, planning and implementation, poverty reduction and economic growth in their home continent and countries is attracting considerable interest amongst policymakers in Africa and elsewhere. Overall, the policy strategy championed by the African Technology Policy Studies Network (ATPS) in the African Manifesto for Science, Technology and Innovation recently launched in Cairo, Egypt in November 2010 has been rather unique. It provides effective models for turning the challenges of "brian drain" into "brain gain" through effective knowledge brokerage and "brain circulation".

Following the launch of the African Manifesto for STI, the ATPS Board encouraged the ATPS management to set up national chapters of the ATPS in selected partner countries, including the United States of America to provide platforms for re-engaging Africans in the Diaspora and friends of Africa in the United States in STI policy dialogues, policymaking and implementation activities for sustainable development in Africa.

The ATPS is a multi-disciplinary network of researchers, practitioners and policy makers that promotes science, technology and innovation (STI) policy research, dialogue and practice, for African Development. With a regional secretariat in Nairobi, Kenya, ATPS operates through national chapters in 30 countries with an expansion plan to cover the entire Africa by 2015. Established in the 1980s, the ATPS enjoys full diplomatic status in the Republic of Kenya.

The Diaspora chapters provide veritable platforms for (i) re-engagement in development programs in the continent without necessarily re-locating to their home countries; (ii) greater knowledge circulation between African countries and Africans in the Diaspora; (iii) consolidating African voices in Northern policy dialogues and informing international development program planning and implementation; (iv) facilitating better understanding and embedding of Northern voices in African policy dialogues and development program planning and implementation; and (v) knowledge networking; amongst others.

The overarching interest interests is to optimise opportunities for harnessing the STI knowledge, skills and experiences of the Diaspora for development in Africa and in the countries of their residence through mutual learning and knowledge circulation.

ATPS USA was founded with the belief that Science, Technology and Innovation present an important opportunity for harnessing the knowledge resources of the Africans in the Diaspora for African development. It brings together the quadruple helix: policy makers, academia, the private sector actors, and civil societies in the USA with interests in fostering sustainable development in Africa to pursue the common goal of promotion, generation, dissemination, use and mastery of science, technology and innovation (STI) for African development, environmental sustainability and global inclusion. The chapter was launched on June 8, 2012 at the Woodrow Wilson Center, in Washington DC in collaboration with the Woodrow Wilson Center's Africa Program and Project on Leadership and Building State Capacity. The ATPS has been participating in the Centre's Southern Voices program which aims to strengthen the voices of the global south in USA policy dialogues.

In liaison with the Wilson Centre, the ATPS is hosting a Chatham House Strategic Planning Roundtable on 29 October 2012.

Objectives

The Strategic Planning Round Table is designed to achieve the following objectives:

- 1. Reflect on the emerging priorities of the ATPS Phase VII Strategic Plan for STI policy research and policy planning for African development in the coming decade and identify leverage points for Africans and friends of Africa living in the United States of America.
- 2. Reflect on previous and ongoing initiatives to strengthen participation of the African Diaspora in policy dialogues, policy planning and implementation in Africa, the USA and elsewhere, and draw lessons for ATPS USA implementation activities.
- 3. Based on 1 & 2 above, identify priority implementation activities and work plan for ATPS USA to upscale the efforts of the ATPS and its partners in promoting the generation, dissemination, use and mastery of science, technology and innovation (STI) for African development, environmental sustainability and global inclusion.
- 4. Identify potential partnerships in the United States for effective implementation of the ATPS phase VII Strategic Plan, 2013 2017.
- 5. Make recommendations for African governments and development partners on how best to harness the wealth of STI knowledge, skills and experiences amongst Africans legitimately living and working in the USA for the mutual development of Africa and vice versa.
